GENERAL INFORMATION AND CONDITIONS

STALLS AND COST

Prices are for the duration of the festival and include VAT.

Art Craft Stall in Marquee	-	R2 500.00 (3m x 3m)
Food Stall in Marquee	-	R3 100.00 (3m x 3m)
Mobile Food Stall	-	R3 450.00 (3m x 3m) : Other dimensions – Quote separately
Electricity	-	R 300.00 (Only one electricity point per stall will be allowed.)

A special price can be negotiated for larger stalls.

A non-refundable administration fee of R90.00 (VAT included) is payable on submission per application.

Please send proof of payment of Admin Fee with your stall application.

No water is supplied to the stalls. Stallholders are to note that they must be in position for all four days of the festival. Applications for the stalls will close on 31 May 2012, after which a selection process will be made.

Stalls will be selected according to type, so as to ensure that a large variety of stalls are available to the public.

The area of your stall has to include your tent pens and/or construction (trailer/caravan tow bar) as well as your signage. Stalls dividers in tents are your responsibility

TRADING HOURS

Friday – Monday 28th Sept – 01st Oct 2012 09h00 – 18h00 (subject to change)

Vendors will only be allowed to off-load in the morning at 07h00 and all vehicles and trailers should be removed from market square by 08h30.

All vehicles failing to leave after this time will be towed away.

No vehicle will drive in the area after 08h30. This will be strictly enforced!!! Vehicle passes will be issued. All stallholders must comply with the regulations attached to this document. Failure to do so will result in a stall holder being evicted, with no refund being given.

All exhibitors must be ready for trading on Friday 28th September 2012 at 09h00.

Only one electricity point per stand in Marquee tents is allowed. Applicants must supply their own extension cords for stalls (min 20m), which should be in accordance with safety regulations. Failure to comply may result in the applicant being kept responsible for all damages caused by defective extension cords or plugs.

Please ensure that your name and business details are clear on the deposit slip and faxed to our office.

Only items listed on the application form may be sold if approved by the organizers and, if goods not listed are sold, it will be confiscated.

Exhibitors are responsible for all accessories, partitions, extension cords, plugs, etc.

Exhibitors are responsible for keeping their stalls clean and tidy.

NGO Stalls

No electricity. A letter confirming the NGO status (Registration document) must accompany the application

NB: Municipal Traders on Market Square are permanent tenants and the Hermanus Whale Festival has no jurisdiction over them or what they sell. They are housed in four corrugated structures.

Detailed security arrangements will be communicated to vendors in time.

No sub-leasing or lending of stalls is permitted.

The Name and Logo of the Two Oceans Hermanus Whale Festival can only be used with prior written confirmation from the Chairman of the Two Oceans Hermanus Whale Festival. Royalties are payable and arrangements must be made ahead of time. Merchandise that does not adhere to these principles will be confiscated.

Stallholders who leave early are not entitled to any refunds and will not be considered for participation again.
